The Aging in New York Fund is dedicated to enhancing the quality of life for older New Yorkers and their families. The Fund's vital efforts to create an age friendly New York focus on maintaining NYC's status as the best place to grow old, identifying cutting edge innovative pilot programming to fill critical gaps in the aging services continuum, and providing fiscal and administrative support to other NYC non-profits in their efforts to offer essential services to seniors.

**Form 990, Part III, Line 4a - Program Service Accomplishments**

As a result of the Fund's affiliation with the City, it is uniquely positioned to understand the pressing needs and/or gaps in services for older adults. Building upon its history and proven track record in devising creative approaches to gaps in services, the Fund initiated a series of educational forums in 2014 to encourage critical dialogue. Following May's inaugural forum on Healthcare Reform and Aging Services Connections, in October 2014, the Fund also co-hosted a Food Insecurity Track at the State Society on Aging of New York Conference. Following this, the Fund developed a smaller community based panel on food insecurity and benefit enrollment and has held four successful locally based forums focusing on food insecurity in the target community and how attendees can take action to make a difference in overcoming issues in their backyards. The fifth forum will be held in April of 2017 in partnership with York College, United Neighborhood House, State Society on Aging of New York and Jamaica Service Program for Older Adults.

Additionally, the Fund is participating in the implementation of a pilot-project in DFTA-funded senior centers based on a model developed through the Community Experience Partnership (CEP), which was designed to engage older adults as leaders of change in their communities. The current project, Older Adults Strengthening

Communities through Food, is conducted in partnership with United Neighborhood Houses, through grants from The New York Community Trust and the Florence V. Burden Foundation, and aims to help redefine the relationship between older adults and their local senior centers and the broader community, moving to a more asset-based approach for working with older adults to enrich current and future programming. Initiatives' goals were to empower older adults to plan and implement neighborhood based health food access projects; build the capacity of senior centers to convene, engage and support older adults to plan, implement and sustain these and other initiatives that strengthen local communities and create a replicable program model for other centers to adopt. Now in year three, an evaluation has proved the success of this model. For example, the project increased the sense of self-worth and fulfillment of participants who are now feeling less isolated through community involvement, improved mental health, reduced depression, achieved weight loss and reduced need for medications. Ten new organizations have volunteered to replicate this model in their centers or NORCS in this last year.

As the charitable arm of DFTA, the Fund assists the agency with creative programming, grant development and fiscal oversight of grant funded projects. These include addressing Late-Life depression and Anxiety under a federal grant with the Joan & Sanford I. Weill Medical College of Cornell University. DFTA's Elderly Crime division has integrated screenings for depression and anxiety into their intake for victims. Those whom staff think would benefit are referred to a mental health clinician placed within the Unit to provide evidence based mental health prevention called PROTECT, which is based on elements of problem solving therapy (PST) and anxiety reduction techniques. This grant has now concluded, having proven its case model and screened nearly 325 clients with one third suffering from clinically significant depression

and 16% endorsing suicidal ideation. For another depression research grant, two month follow-up interviews were conducted with 400 participants of depression screening workshops. Clients needing services were referred for treatment and the evaluation of these programs helped inform the City's current mental health initiative for older adults.

On September 30, 2016 the fund concluded its contract with the New York State Office for Aging, a \$1.9 million contract from New York State Governor Andrew Cuomo's office funded by the Superstorm Sandy Social Service Block Grant, a federal program. The Fund collaborated with the DFTA and two main sub-awardees: The Joan & Sanford I. Weill Medical College of Cornell University Department of Psychiatry and Peer Place. The project, Sandy Mobilization Assessment, Referral and Treatment for Mental Health Project (SMART-MH) identified the mental health and social support needs of older adults in areas affected by Hurricane Sandy. The approach is modeled after the mental health initiatives employed after Hurricane Katrina to build community resilience, and involved mental health assessments, referral and treatment services. SMART-MH met or exceeded all program goals. Using community participatory engagement strategies to identify need and resources in the community, SMART-MH staff reached out to individuals and organizations in the 24 affected communities, representing all five boroughs of New York City. SMART-MH bi-lingual and bi-cultural staff were able to reach out to seniors speaking English, Spanish, Russian, Cantonese, Mandarin, and Japanese, making contact with 254 community organizations and 25 health organizations to learn about the community and describe the objectives of SMART-MH. Staff members conducted 397 presentations with community organizations and health partners, and 341 presentations with older adults and their caregivers. 5,041 seniors and caregivers attended these presentations. Staff members distributed 9,432 informative brochures

highlighting benefits and entitlements and emergency preparedness procedures. 502 flyers were posted about the program. In addition, 7,847 outreach materials were distributed, which was found incredibly helpful in engaging older adults for service. 2,829 seniors received case management services during the course of grant, exceeding the goal of 2,133; 4,835 seniors received information and referral services during the course of grant, exceeding the goal of 4,293; 306 seniors who received mental health services through SMART-MH clinicians, exceeding the goal of 230. During the course of the grant, 458 individuals were found to be in need of mental health services, representing 16.2% of all those assessed for service. Of those 458 in need of service, 306 seniors received mental health services, representing 67% of those in need of service. During the course of the grant, 585 seniors were found to be in need of social services, representing 20.7% of all those assessed for service, all of which were referred for services. Although this program will not continue, New York City has made funds available to implement a program based on the core principles of SMART-MH. During the course of the next three years, DFTA has contracted with four licensed mental health programs to embed licensed mental health clinicians in 25 senior centers within the next three years (programming is in progress at the 15 sites which have been identified for this year). Five of the 25 sites were also locations that were served under SMART-MH. Clinicians will take what was learned from SMART-MH and engage in creative engagement activities, in order to de-stigmatize mental health. In addition, clinicians will offer mental health counseling in the comfort of the senior center twice a week. SMART-MH clients that required long term treatment are able to receive mental health services within the five sites where the new geriatric mental health program will reside. Clients that reside in other communities and required long term treatment were referred to mental health clinics in their areas.
